Our enterprise was founded in 1992 and nowadays has formed trading and manufacturing traditions. Traditionally Ukraine has been a grain processing and grain producing country. The climate and unique fertile land surfaces provide considerable grain harvests and allow to produce high quality cereals. Our enterprise belongs to a flour-grinding industry. An administrative-producing complex is located in Chernigov city. The complex for production of grain products and mixed feedings as well as grain elevators with storing capacity up to 22 thousand tons are located 20 km away from the city.

Grain processing capacity of our plants allows to process up to 160 tons/day. The main products is the range of cereals and flour (peas polished (whole, split), corn grits, corn flour, millet polished, unground buckwheat, pearl barley and fine-ground barley, semolina. The second direction in commodity turnover is a wholesale of grain, pulses and food products . We supply soy beans, corn forage, millet, rye, oats, confectionery sunflower seed, lupine, coriander seed, mustard seed, vetch, broad beans, flax seed and green lentil. By request we can supply you with wheat flour, rye flour, sunflower oil, white beet sugar and other foodstuffs of Ukrainian manufacture.


